## 3. Minutes of Previous Meeting

# 5. Youth Committee Report

Greg presented the Youth Committee report with the following points:

- **a.** He had received a number of proposals from the junior members to become part of the committee. These positions need to be confirmed.
- **b.** He reported that exams will get in the way for a couple of the Youth Members, namely Josh, Arron & Eve



- c. The Youth Commmittee has discussed the possibility of holding some form of competition at Newark CC lake. The driving force is believed to be the 'Ski Slope'
- **d.** The Youth Committee have also asked for more competitions with prizes.
- e. They have also discussed to acquire some 'Slea Paddlers' bracelets to sell to members. Greg has proposed that a sum of £80 would be needed for the initial stock of 100 bracelets.
- f. Greg announced that Arron would be willing to build the Youth Committees web pages and asked for access to the main site. This was declined by Barry, but said that if Arron provided the content then he would upload or if he provided the actual web pages would link them into the main site.

7. Treasurer's Report

Steve Walker went through the attached report.

It was noted that the club has £4434.23 available funds. However with future expenditure of £745 for pool hire, £445 for club affiliation in April, £630 (approx) for insurance in May and £250 (approx) for coaching & FA fees reduces this figure to £2364.23 Jon provided figures for replacement kit that was or is to be written off from the recent Kit check of £450, plus the acquisition of a pre-loved canoe with a value no greater that £450 takes the available funds down to £1464.23

Treasurers report was proposed by Miriam Holden and seconded by Steve Callaby subject to audit.

### 8. Membership

Brian announced that we currently have 25 paid up members but were expecting at least another 20 of last years members are likely to re-join. However he had doubts that the remainder would not re-join.

After a brief discussion on current members it was proposed by Paul that no one would be allowed to join in with the Club sessions if they are not fully paid up which was agreed. This will not include those prospective members who are still within their '3 Taster sessions'.

### 9. Coaching Development Officer

Paul discussed those requiring FA update for Barry who is to look for a course.

Also discussed was the WWSR for Dan & Matt but is no further forward with this one

Greg to be put forward for his Level 1 coaching, FSRT along with Arron & Josh when they are ready.

Paul also proposed a Coaching Meeting on Sunday 02 Apr 2017 at 19:00 in the Barge & Bottle. Invites are to be put out.

#### 10. Child Protection

### 14. Club Mark

Barry said that the new extended certificate is on the website.

## 15. Policy Review

Two documents were presented for review:

### Equality & Child Protection.

Paul presented an Equality document which Barry identified as not being the current Equality Policy and argued that we could not review a document that had not been presented. He stated that the actual document was on the website. It was agreed that this would be held over to the next meeting so that all committee members had an opportunity to study both the existing policy and the proposed one.

Paul presented the Child Protection Policy and whilst reviewing it was mentioned that this should be extended to include 'Vulnerable Adults'. At this point is was agreed that Miriam & Brian should look at the BCU policy with a view to adopting it for our own use.

### 16. Any other business

**General:** Vice Chair role needs to be filled which is to be advertised in Rapid Times. Several people nominated Paul, who dismissed the idea.

**Adam:** mentioned that the trailer lights were broken. The cost to be bourn from the £900 for replacement equipment

### Brian:

Discussed a supplier for Club clothing, Tee Shirts etc it was believed that Dane had made some progress with this.

That Carrs Grammar School were going to include a 'Swimming Lake' in their re-build and it may be something we, as a club could approach the school to use as our training lake.
