## 3. Minutes of Previous Meeting

#### 5. Treasurer's Report

Dane Butler reported that he has £52.87 in hand and £1,790.99 in the Bank. #### 7. Coaching Development Officer

Kevin Matthews reported on the recent Coaches Meeting and he confirmed that a further Coaches meeting would be held before the outside sessions next year.

The meeting discussed paddle power and delivery of paddle power in the pool.

It was suggested and agreed that Coaches should wear T shirts in the pool with the word "Coach" on. Barry Mair confirmed he would order various sizes. It was agreed that navy would be the best colour.

Kevin Matthews reported that he hoped to be able to obtain a Notice Board for the Pool to put up details of any future events.

Dane Butler reported that a Disability Inclusion Course is to be held at Yarborough which is run for the Scouts if anyone is interested in attending they are to speak to Dane.

# 9. <u>Child Protection</u>

Kevin Matthews reported that we should have two Child Protection Officers who are now to be called Child Welfare Officers. One male and one female. As Steve Callaby has done the Course it was suggested that he be the male Child Welfare Officer which he agreed.

The meeting agreed that the Club should complete the CRB forms for Tony and Lorraine Baker and it was agreed that Paul Pattinson, Brian and John Hird should also complete the CRB forms.

Kevin Matthews reported from the Time to Listen Course that there should always be two adults in the changing room and a discussion took place as to how this could be dealt with on a Saturday and it was agreed that this must be monitored carefully.

#### 10. Any other Business

Dale reported that he has made enquiries in relation to the situation at Newark Weir and understands that centre island is owned by British Waterways. The Trent is a navigational river and therefore the Fishing Club can not stop paddlers going down the Weir and interestingly the fishermen are not allowed to fish within 50ft of the Weir.

Paul Pattinson asked about progression for people joining the Club to show what they have achieved. Barry Mair confirmed that he was going to deliver paddle power for the children both in the pool and outside.

Dane suggested that if there were any certificates then perhaps they could be presented at the forthcoming AGM.

Paul also suggested that for those new members joining the Club perhaps in April the Club could do a dedicated induction course over six weeks. Discussion did take place and this will be considered in

the future. However, difficulties will arise in ensuring that people turn up every week.

Megan Hird suggested that the Club have a kayaking trip to the Alps and it was suggested that Megan should research this and then present the information to the Committee at a later date.

Kevin Matthews reported that Lisa Pattinson had found a Scout Hostel in Llangollen. Once he has the information then he will look into booking it for the Llangollen trip on the 1 and 2 April

Megan Hird mentioned that she would like to attend Holme Pierrepont for some of her outdoor sessions. Kevin said that he would note that and it would be discussed with the Coaches. Megan also said that she would like to do her Three Star..

Steve Callaby asked about the missing kit and asked whether all kit had been returned. He also pointed out that a cover will be needed for the trailer for the Winter. He will look into costing to buy a couple of tarpaulins.

Kevin Matthews suggested that the Club have Hoodies and now would be a perfect time for Hoodies for people to buy as Christmas presents. Barry Mair agreed to research Hoodies and the membership agreed that he should purchase Hoodies provided the price was reasonable.

The meeting was reminded that the symptoms of Weils disease are 'flu like symptoms which appear between two and ten days of paddling and how important it is for paddlers to contact their Doctor and explain they have been paddling.
